COURSE DESCRIPTION

This is the fourth course in the Immigration Practitioner Certificate Program. This course presents the concepts and documentation relating to permanent residence: Federal Economic Class and Provincial/Territorial Programs. This course provides case studies for the learner, focusing on Federal Skilled Workers, Canadian Experience Class, Provincial Nominee Programs, Business Immigrants, and Caregivers.

LEARNING OUTCOMES

By the end of this course, through in-class and online activities and assessments, learners will demonstrate an understanding of the following:

- the general provisions for applying for permanent residence
- the three classes of permanent residents
- the general rights and obligations of permanent residents
- the Federal Skilled Worker Program including an ability to assess a case and complete an application
- how LMIA's relate to the federal skilled worker program
- the Canadian Experience Program including ability to assess a case and complete an application
- the Express Entry (EE) system, including the ability to assess an applicant's score and potential to receive an invitation to apply
- the Alberta Immigrant Nominee Program (AINP)
- the PNP programs of other Provinces, Quebec Programs, and the Atlantic Immigration Pilot Program
- the Start-up Business Class
- the Self-employed Class
- the Programs for Caregivers

Learners will also demonstrate an ability to undertake the following:

- assess a Federal Skilled Worker case and complete an application
- assess a Canadian Experience Class case and complete an application
- assess an Express Entry applicant’s score and potential to receive an invitation to apply
- advise clients on how to improve their chances of success in getting an invitation in the Express Entry Program
- assess a case and complete an application in the Start up Business Class
- assess a case and complete an application in the Self-employed Class
- assess a case and complete an application in the programs for caregivers

PERFORMANCE EVALUATION

Learner progress will be assessed based on a combination of participation, attendance, assignments, quizzes and activities completed throughout the course and a multiple choice final exam. Participation, attendance, assignments, quizzes and activities will count for 50% of the course mark and the final exam will count for 50% of the course mark.
