LEARNING OUTCOMES

Learners will demonstrate an understanding of the concepts, policies and related documentation regarding refugees and protected persons. By the end of this course, through in-class and online activities and assessments, learners will demonstrate an understanding of the following:

- the history of Refugees in Canada
- the relevant sections of the Immigration and Refugee Protection Act, Immigration and Refugee Protection Regulations, and other relevant documents pertaining to refugees
- the refugee determination system in Canada
- the refugee determination system outside of Canada
- pre-removal risk assessments
- current Canadian legal terminology applicable to Canadian Immigration Law and other relevant legislation
- the impact of verbal and non-verbal communication
- the federal departments and agencies that have a role in immigration services
- administrative agencies and tribunal processes
- appeals and judicial reviews

Learners will also demonstrate an ability to undertake the following:

- search relevant immigration-related websites
- employ research methodologies to solve problems
- collect, analyze and organize information
- use Canadian legal terminology
- research, develop and implement a case strategy
- interpret and apply statutes and regulations
- review cases and present immigration options
- review cases and identify required documentation for application
- write narratives/submission letters and complete appropriate applications for immigration options
- research and analyze relevant sources and references to complete applications
- complete application forms relating to the different categories of refugees according to the Immigration and Refugee Protection Act and Immigration and Refugee Protection Regulations
- communicate effectively and appropriately with clients, government, and other entities
- prepare business documents
- deliver presentations that are well-organized, concise and use appropriate aids
- prepare cases
- present evidence and testimony
- represent clients at tribunals
- research, prepare for and conduct cross-examinations
- prepare and deliver oral and written submissions
- prepare and present opening statements, rebuttal and closing arguments

PERFORMANCE EVALUATION
